It is understood and agreed that as a condition of membership, I will attend the mandatory indoctrination as scheduled if necessary and to familiarize myself with the Bylaws of the MBOR and the REALTOR® Code of Ethics, and if elected to membership to abide by same. Upon termination of membership for any reason, I will discontinue the use of the term REALTOR® and return to MBOR all certificates, signs, seals or other indication of membership to MBOR, NJAR and NAR. I shall also remove any indication of membership in the REALTOR® organization from my signs, stationery, business cards, envelopes, advertising, web site and any other place or device on which it may appear.
